

## **Congressional Activities Report for the Council Coordination Committee**

### **Submitted to the North Pacific Fishery Management Council**

**September 1, 2018**

#### **Overview of Work Provided:**

- Provided information on Congressional activities of interest to the Regional Fishery Management Councils (see below for updates on, and links to, House and Senate Magnuson-related hearings and other hearings of interest)
- Monitored Congressional hearing and markup schedules related to fisheries management, international fisheries, or other issues of interest to the Regional Fishery Management Councils
- Provided notice of legislation of interest moving through the House, Senate, or to the President
- Provided Regional Fishery Management Councils' meeting schedule information to House and Senate staff for consideration in the scheduling of Congressional activities related to the Magnuson-Stevens Act reauthorization or other fisheries issues of interest to the Councils
- Met with Congressional staff to discuss upcoming activities, hearings and legislation
- Provided Council information to appropriate Congressional staff on fisheries issues of interest

#### **Comings and Goings:**

**Congressional Resignations, Retirements, etc.** - The next election is approximately 9 weeks away. In November 2018, all 435 Members of the House of Representatives are up for reelection and 35 total Senate seats are up for election (33 of the 100 Senate seats are up for election + 1 special election in Minnesota + 1 likely special election to fill the seat of retiring Senator Cochran (R-Mississippi)).

Three Senators have announced they will not seek reelection and 59 House Members have announced that they are either retiring, running for other office, or have already lost their primary for their current seat or the primary for another office (and one House Member has died). Interestingly, 8 full committee chairmen in the House of Representatives - and the Speaker of the House - are leaving at the end of the 115<sup>th</sup> Congress. In addition, of the 35 Senate seats up for election in 2018, 17 of those seats are from coastal states and 8 of the seats up for election are currently held by members of the Senate Commerce, Science, and Transportation Committee. (*Note: In a recent primary, Delegate Madeleine Bordallo (D-Guam) was defeated in the democrat primary.*)

#### **Timing for the remainder of the 115<sup>th</sup> Congress:**

With the elections coming soon, Members of both the House and Senate will be spending more time in their districts meeting with constituents. While the House of Representatives was out of session for most of August for the August District Work Period, the Senate remained in session

for 3 weeks in August. For the remainder of the year, the schedule for the House of Representatives notes 19 days of session between the August District Work Period and October 12 (the target for returning to their districts before the election) and 16 days of session after the election (lame duck session).

The Senate's schedule is not as clear, but it will generally be in session approximately the same weeks as the House of Representatives; however, because the Senate stayed in session during most of August, it may make adjustments to its schedule to allow Senators to travel to their home States for longer weekends than the House.

While both chambers have passed a number of appropriation bills (see below for more details), these bills still need to be conferenced and there are a number of appropriation bills that need to be passed before the end of the fiscal year or a continuing resolution will need to be considered for those unappropriated agencies.

As always, this schedule is subject to change.

#### **Upcoming Items of Interest:**

- On Wednesday, September 5, 2018, at 10:15 a.m., the House Natural Resources Committee will hold a markup of 12 bills of which one may be of interest to the Councils:
  - H.R. 6665 (Rep. Madeleine Z. Bordallo), To amend the Outer Continental Shelf Lands Act to apply to territories of the United States, to establish offshore wind lease sale requirements, to provide dedicated funding for coral reef conservation, and for other purposes. "Offshore Wind for Territories Act".
- On Wednesday, September 5, 2018 at 10:00 a.m., the Senate Commerce, Science, and Transportation Committee will hold an Executive Session to consider a number of legislative measures and nominations. (*Note: Legislation of possible interest is in **bold.***)

The legislation to be considered includes:

- **S. 1965, Allowing Alaska IVORY Act** (Sen. Sullivan, R-Alaska);
- **S. 2773, Driftnet Modernization and Bycatch Reduction Act** (Sen. Feinstein, D-California);
- S. 3367, Department of Transportation Reports Harmonization Act (Sen. Thune, R-South Dakota); and
- H.R. 4323, Supporting Veterans in STEM Careers Act (Rep. Dunn, R-Florida).

The nominations to be considered include:

- Nomination of Rick Dearborn, of Oklahoma, to be a Director of the Amtrak Board of Directors;
- Nomination of Kelvin Droegemeier, of Oklahoma, to be Director of the Office of Science and Technology Policy;

- Nomination of James Morhard, of Virginia, to be Deputy Administrator of the National Aeronautics and Space Administration; and
- Nomination of Joel Szabat, of Maryland, to be an Assistant Secretary of Transportation.

- On Tuesday, August 28, 2018, the Senate Commerce, Science, and Transportation Committee’s Subcommittee on Oceans, Atmosphere, Fisheries, and Coast Guard, held a hearing entitled, “Harmful Algal Blooms: The Impact on Our Nation’s Waters”.

According to the Committee website, the hearing was expected to “examine Harmful Algal Bloom events in the U.S. and provide an update on current research, technology, and monitoring techniques.”

- On Wednesday, August 1, 2018, at 9:45 a.m., the Senate Commerce, Science, and Transportation Committee held an Executive Session considered a number of bills and two nominations (bills of possible interest are in bold):
  - S. 3277, the "Space Frontier Act of 2018" (Sen. Cruz, R-Texas), a bill to reduce regulatory burdens and streamline processes related to commercial space activities, and for other purposes;
  - S. 2242, the “COASTAL Implementation Act of 2017” (Sen. Wicker, R-Mississippi), a bill to amend the Omnibus Public Land Management Act of 2009 to clarify the authority of the Administrator of the National Oceanic and Atmospheric Administration with respect to post-storm assessments;**

- S. 2861, the "Passenger Rail Crew Protection Parity Act" (Sen. Duckworth, D-Illinois), a bill to prosecute, as a Federal crime, the assault or intimidation of a passenger train crew member to the same extent as such actions against aircraft crew members are prosecuted;

- S. 3119, the "Endangered Salmon Predation Prevention Act" (Sen. Risch, R- Idaho), a bill to allow for the taking of sea lions on the Columbia River and its tributaries to protect endangered and threatened species of salmon and other nonlisted fish species;

- S. 3143, the "National Quantum Initiative Act" (Sen. Thune, R-South Dakota), a bill to provide for a coordinated Federal program to accelerate quantum research and development for the economic and national security of the United States;

- S. 3265, (Sen. Baldwin, D-Wisconsin), a bill to require the Secretary of Commerce to undertake certain activities to support waterfront community revitalization and resiliency;

- S. 3273, (Sen. Wicker, R-Mississippi) a bill to improve the safety, efficiency, and reliability of the movement of goods through ports and intermodal connections to ports;

and the nomination of Martin J. Oberman, of Illinois, to be a Member of the Surface Transportation Board.

*[Note: S. 2773, the "Driftnet Modernization and Bycatch Reduction Act" (Sen. Feinstein, D-California), a bill to improve the management of driftnet fishing and the nomination of Rick A. Dearborn, of Oklahoma, to be a Director of the Amtrak Board of Directors were removed from consideration for this session.]*

- On Tuesday, July 24, 2018, the Senate Commerce, Science, and Transportation's Subcommittee on Oceans, Atmosphere, Fisheries, and Coast Guard, held a hearing entitled, "NOAA's Blue Economy Initiative: Supporting Commerce in American Oceans and Great Lakes". According to the Committee, the hearing "will examine the National Oceanic and Atmospheric Administration's initiative to support the sectors of American commerce that rely upon the oceans and Great Lakes."

The only witness was Rear Admiral Tim Gallaudet, Ph.D., USN Ret., Assistant Secretary of Commerce for Oceans and Atmosphere and Acting Under Secretary of Commerce for Oceans and Atmosphere, National Oceanic and Atmospheric Administration.

- On Wednesday, July 18, 2018, the House Natural Resources Committee marked up 10 bills (at least one may be of interest – in **bold**). The bills being marked up include:
  - H.R. 5171 (Rep. Scott R. Tipton of Colorado), a bill to amend the Omnibus Parks and Public Lands Management Act of 1996 to provide for the establishment of a Ski Area Fee Retention Account. Ski Area Fee Retention Act.
  - H.R. 5347 (Rep. Mark E. Amodei of Nevada), a bill to facilitate resolution of environmental remediation and reclamation, resolve potential liability of the United States, and promote economic development in Lyon County, Nevada, and for other purposes. Lyon County Economic Development and Environmental Remediation Act.
  - H.R. 5532 (Rep. James E. Clyburn of South Carolina), a bill to redesignate the Reconstruction Era National Monument as the Reconstruction Era National Historical Park, and for other purposes. Reconstruction Era National Historical Park Act.
  - H.R. 5556 (Rep. Paul A. Gosar of Arizona), a bill to provide for transparency and reporting related to direct and indirect costs incurred by the Bonneville Power Administration, the Western Area Power Administration, the Southwestern Power Administration, and the Southeastern Power Administration related to compliance with any Federal environmental laws impacting the conservation of fish and wildlife, and for other purposes. Environmental Compliance Cost Transparency Act of 2018.**
  - H.R. 5923 (Rep. Bruce Westerman of Arkansas), a bill to direct the Secretary of Agriculture to exchange certain public lands in Ouachita National Forest, and for other purposes. Walnut Grove Land Exchange Act.
  - H.R. 5979 (Rep. Harold Rogers of Kentucky), a bill to establish the Mill Springs Battlefield National Monument in the State of Kentucky as a unit of the National Park System, and for other purposes. Mill Springs Battlefield National Monument Act.
  - H.R. 6038 (Rep. Kevin Cramer of North Dakota), a bill to establish a procedure for the conveyance of certain Federal property around the Dickinson Reservoir in the State of North Dakota.
  - H.R. 6039 (Rep. Kevin Cramer of North Dakota), a bill to establish a procedure for the conveyance of certain Federal property around the Jamestown Reservoir in the State of North Dakota, and for other purposes.
  - H.R. 6040 (Rep. Mark DeSaulnier of North Dakota), a bill to authorize the Secretary of the Interior to convey certain land and facilities of the Central Valley Project. Contra Costa Canal Transfer Act.
  - H.R. 6146 (Rep. Paul A. Gosar of Arizona), a bill to authorize, direct, expedite, and facilitate a land exchange in Yavapai County, Arizona, and for other purposes. Cottonwood Land Exchange Act of 2018.

- On Wednesday, July 18, 2018, the Senate Commerce, Science, and Technology Committee held a hearing titled “SHARKS!”

According to the Committee, the hearing was scheduled to “examine innovations in shark research techniques and technology. This research is being used to improve American lives by increasing our understanding of oceans and fisheries, creating new innovations in engineering, and searching for medical breakthroughs.”

### **Magnuson-Stevens Act Reauthorization Related Hearings or Mark-ups:**

- On July, 11, 2018, H.R. 200, the Strengthening Fishing Communities and Increasing Flexibility in Fisheries Management Act, passed the House of Representatives this evening by a vote of 222-193.

Below are the amendments that were offered and the vote outcome on each amendment (vote outcome in **bold red**):

- Young (R-Alaska) - Manager's Amendment to strikes section 302(c) and 307, and modifies sections 205, 207, 304, 306, 406, and 408. The amendment also includes a new

section regarding voting procedures for the Western Alaska Community Development Quota Program's administrative panel. **Passed by voice vote.**

- Courtney (D-Connecticut) - to create an industry-based pilot trawl survey for the New England and Mid-Atlantic Fishery Management Council regions. **Passed by voice vote.**

- Langevin (D-Rhode Island) - to provide voting representation for Rhode Island on the Mid-Atlantic Fishery Management Council (MAFMC). **Failed by voice vote.**

- Huffman (D-California) - to ensure that rebuilding plans are successful in rebuilding overfished fish stocks. **Failed by voice vote.**

- Frankel (D-Florida) - to waive compensatory mitigation requirements for maintenance dredging projects in certain inland waterways, inlets, or harbors. **Passed by voice vote.**

- Graves (R-Louisiana) (MODIFIED\*) - to require the Comptroller General to submit a report to Congress on resource rent of LAPPs in the Gulf of Mexico and South Atlantic Fishery Management Councils, ways to the Treasury can reclaim that resource rent, and ways to eliminate fiduciary conflicts of interest in the South Atlantic and Gulf of Mexico Fishery Management Councils. **Passed by voice vote.**

- Keating (D-Massachusetts) - to direct the Secretary to submit a plan to establish fully operational electronic monitoring and reporting procedures for the Northeast Multispecies Fishery. **Passed by voice vote.**

- Poliquin (R- Maine) - to require NOAA to conduct a study on all fees it charges the lobster industry and report those findings to Congress. **Passed by voice vote.**

- Zeldin (R-New York) - to lift the ban on striped bass fishing in the Block Island transit zone between Montauk, NY and Block Island, RI. **Passed by voice vote.**

- Keating (D-Massachusetts) - to direct the Secretary to use funds collected from penalties and fines for monitoring in addition to traditional enforcement activities. **Passed by voice vote.**

- Gaetz (R-Florida) (MODIFIED\*) - to reward the elimination of lionfish from United States waters by allowing individuals to exchange lionfish for tags authorizing fishing for certain species in addition to the number of such species otherwise authorized to be taken by such individuals. **Passed by voice vote.**

*\* Note: As you may have noted, two of the amendments that were passed were "modified". I do not have copies of the modified amendments (as you may have heard, some of the changes were made by hand as the Members were sitting on the House Floor so it may be a while before I can get a copy of what actually passed).*



Following the vote on the 11 amendments, the House voted on a Motion to Recommit and then on final passage.

The Motion to Recommit dealing with President Trump's trade policy and its effect on the domestic seafood industry – **failed by recorded vote (187-228)**.

Final Passage of H.R. 200 – **passed by recorded vote (222-193)**.

- On February 28, 2018, the Senate Commerce, Science, and Transportation Committee met to consider four nominations to the Federal Trade Commission and to mark up S. 1520, the “Modernizing Recreational Fisheries Management Act of 2017”. A substitute amendment, offered by Senator Wicker (R-Mississippi) the sponsor of the legislation, was offered. An amendment by Senator Blumenthal (D-Connecticut) was also offered. The bill, as amended by the Wicker substitute and the Blumenthal amendment, was passed by voice vote. However, five Senators then asked to be recorded as “no” votes on the bill – Senator Udall (D-New Mexico), Senator Cortez Masto (D-Nevada), Senator Markey (D-Massachusetts), Senator Cantwell (D-Washington), and Senator Blumenthal (D-Connecticut). *(Note: While S. 1520 does not reauthorize the Magnuson-Stevens Act, it does make significant amendments to the Act.) (Note: A summary of the bill, as amended, has been sent out separately.)*

Following the vote, Senator Sullivan (R-Alaska) noted that the committee would continue to refine S. 1520, but also work on “reauthorizing, updating, and improving the Magnuson-Stevens Act” and that he was “looking forward to bipartisan support on that broader bill from this Committee and trying to move it onto the Floor sometime this year.”

- On September 26, 2017 the House Natural Resources Committee's Subcommittee on Water, Power and Oceans held a legislative hearing on four bills related to the reauthorization of the Magnuson-Stevens Fishery Conservation and Management Act. The bills are:

**Other Recent Hearings, Markups, or Other Activities of Potential Interest:**

- On Tuesday, June 26, 2018, the full House of Representatives took up and passed H.R. 2038, the Endangered Salmon and Fisheries Predation Prevention Act (Sponsored by Rep. Herrera Beutler, R-Washington) today. Three amendments were made in order by the rule but only two were offered.

The amendment offered by Congressman Kilmer (D-Washington) to limit the application of the bill to only sea lions, rather than all pinnipeds was passed by voice vote.

The amendment offered by Congressman Vargas (D-California) to mandate that the Secretary of the Interior produce a report to Congress on the potential impact of the lethal taking of California Sea Lions on the recovery of Salmonid stocks was modified by unanimous consent and passed by voice vote. I do not have a copy of the modified amendment.

The bill was then passed by a roll call vote of 288 - 116.

- On August 3, 2017, the Senate passed and on August 18, 2017, the President signed H.R. 374, a bill to remove the sunset provision of section 203 of Public Law 105–384, and for other purposes (Rep. Beutler, R-Washington). The bill was introduced on January 9, 2017 and referred to the House Natural Resources Committee. This legislation passed the House of Representatives on January 30, 2017 under Suspension of the Rules. The Senate passed the bill on August 3, 2017 without amendment by Unanimous Consent. The President signed the legislation on August 18, 2017 and the legislation became P.L. 115-49.

### **Appropriations – Fiscal Year 2019:**

Of the 12 appropriations bills generally enacted by Congress, none have been signed into law for Fiscal Year 2019. Both the House and Senate Appropriations Committees have reported all 12 appropriations bills out of Committee.

According to a Senate staffer, Congress is likely to consider these 12 bills in packages – probably 4 or 5 packages.

Both the House and the Senate have passed a package containing: the Energy and Water appropriations bill; the Legislative Branch appropriations bill; and the Military Construction-Veterans Affairs appropriations bill. The differences between the packages must still be

negotiated and the package must then pass both house of Congress again before going to the President for his signature.

Both the House of Representatives and the Senate have passed a package containing: the Interior appropriations bill; and the Financial Services and General Government appropriations bill. The differences between the packages must still be negotiated and the package must then pass both house of Congress again before going to the President for his signature.

Both the House of Representatives and the Senate have passed the Defense appropriations bill. The differences between the packages must still be negotiated and the package must then pass both house of Congress again before going to the President for his signature.

According to staff, the Commerce/Justice/Science appropriations bill is likely to be considered packaged up with the Homeland Security appropriations bill and State /Foreign Operations appropriations bill.

The schedule for consideration of these bills or packages is unknown; however, recent press reports have speculated that consideration of at least a few of the packages may be pushed until after the election in November - which will require a Continuing Resolution at some point before the end of Fiscal Year 2018 (September 30, 2018) in order for those agencies not appropriated to remain operating. Stay tuned.

### **Legislation of Interest and Legislative Action Updates (new bills or Congressional actions in red):**

#### **House Fisheries-Related Bills:**

**H.R. 200**, the “Strengthening Fishing Communities and Increasing Flexibility in Fisheries Management Act” (Rep. Young, R-Alaska). Introduced on January 3, 2017 and referred to the House Natural Resources Committee. **On September 26, 2017 a hearing on this legislation was held by the House Natural Resources Committee’s Subcommittee on Water, Power and Oceans. On December 13, 2017, the House Natural Resources Committee ordered the legislation to be reported by recorded vote: 23 – 17. On July 11, 2018, the House of Representatives passed H.R. 200 by a roll call vote of 222-193. On July 12, 2018, the bill was received in the Senate and referred to the Senate Commerce, Science, and Transportation Committee.**

**H.R. 204**, the “Genetically Engineered Salmon Labeling Act” (Rep. Young, R-Alaska). Introduced on January 3, 2017 and referred to the House Energy and Commerce Committee.

**H.R. 205**, a bill to “amend the Federal Food, Drug, and Cosmetic Act to require labeling of genetically engineered fish” (Rep. Young, R-Alaska). Introduced on January 3, 2017 and referred to the House Energy and Commerce Committee.

**H.R. 206**, the “Prevention of Escapement of Genetically Altered Salmon in the United States Act (Rep. Young, R-Alaska). Introduced on January 3, 2017 and referred to the House Natural Resources Committee.

**H.R. 214**, the “American Fisheries Advisory Committee Act” (Rep. Young, R-Alaska). Introduced on January 3, 2017 and referred to the House Natural Resources Committee.

**H.R. 223**, a bill to “prohibit the Secretary of the Interior and the Secretary of Commerce from authorizing commercial finfish aquaculture operations in the Exclusive Economic Zone except in accordance with a law authorizing such action.” (Rep. Young, R-Alaska). Introduced on January 3, 2017 and referred to the House Natural Resources Committee.

**H.R. 374**, a bill to remove the sunset provision of section 203 of Public Law 105–384, and for other purposes (Rep. Beutler, R-Washington). Introduced on January 9, 2017 and referred to the House Natural Resources Committee. *(Note: This is the bill to extend state jurisdiction over the Dungeness crab fishery.)* This legislation passed the House of Representatives on January 30, 2017 under Suspension of the Rules. The Senate passed the bill on August 3, 2017 without amendment by Unanimous Consent. The President signed the legislation on August 18, 2017 and the legislation became P.L. 115-49.

**H.R. 943**, the “Finding Innovative Lionfish Elimination Technologies Act of 2017”, (Rep. Curbelo, R-Florida), to authorize the Secretary of Commerce to award competitive grants to combat the certain species of lionfish in the Atlantic Ocean and the Gulf of Mexico. Introduced on February 23, 2017 and referred to the House Natural Resources Committee.

**H.R. 1195**, the “Local Fishing Access Act”, (Rep. Zeldin, R-New York), to authorize the Secretary of Commerce to permit striped bass fishing in the Exclusive Economic Zone transit zone between Montauk, New York, and Point Judith, Rhode Island, and for other purposes. Introduced on February 16, 2017 and referred to the House Natural Resources Committee.

**H.R. 1382**, the “Give Our Fishermen Immediate Snapper Help Act” or the “GOFISH Act”, (Rep. Weber, R-Texas), to establish requirements and restrictions for the commercial, charter, and recreational red snapper fishing seasons in the Gulf of Mexico for the 2017 and 2018 fishing seasons, and for other purposes. Introduced on March 7, 2017 and referred to the House Natural Resources Committee.

**H.R. 1411**, the “Transparent Summer Flounder Quotas Act”, (Rep. Pallone, D-New Jersey), to continue in effect for the 2017 and 2018 fishing seasons certain fishing specifications for the summer flounder fishery, and for other purposes. Introduced on March 7, 2017 and referred to the House Natural Resources Committee. A hearing on this legislation was held on April 4, 2017 by the House Natural Resources Committee’s Subcommittee on Water, Power and Oceans.

**H.R. 1456**, the “Shark Fin Sales Elimination Act of 2017”, (Rep. Royce, R-California), to prohibit the sale of shark fins, and for other purposes. Introduced on March 9, 2017 and referred to the House Natural Resources Committee. A hearing on this legislation was held on April 17, 2018 by the House Natural Resources Committee’s Subcommittee on Water, Power and Oceans.

**H.R. 1887**, a bill to amend the Billfish Conservation Act of 2012 to clarify an exemption for traditional fisheries and markets (Rep. Diaz-Balart, R-Florida). This legislation is similar to the Senate billfish bill (S. 396) but not identical. Introduced on April 4, 2017 and referred to the House Natural Resources Committee.

**H.R. 2023**, the “Modernizing Recreational Fisheries Management Act of 2017”, (Rep. Graves, R-Louisiana), the bill would amend the MSA, but would not reauthorize the Act. The bill would: 1) establish a process for allocation review for SA and Gulf (based on NAS guidelines); 2) allow alternatives for management of recreational fisheries; 3) institute a moratorium on any new catch shares for recreational only or mixed-sector fisheries; 4) provide flexibility in rebuilding timeframes; 5) provide flexibility in establishing ACLs; 6) implement new requirements prior to authorizing Exempted Fishing Permits; 7) require increased data incorporation in stock assessments, etc.; 8) require that the Secretary establish new partnerships with States for recreational data collection (NAS study). Introduced on April 20, 2017 and referred to the House Natural Resources Committee. **On September 26, 2017 a hearing on this legislation was held by the House Natural Resources Committee’s Subcommittee on Water, Power and Oceans.**

**H.R. 2079**, the “Young Fishermen’s Development Act of 2017”, (Rep. Young, R-Alaska), a bill to preserve United States fishing heritage through a national program dedicated to training and assisting the next generation of commercial fishermen. (Requires the creation a new grant program to provide training, education, outreach and technical assistance to “young fishermen” for new entrants, captains, crew, etc.) Introduced on April 24, 2017 and referred to the House Natural Resources Committee.

**H.R. 2203**, the “Coral Reef Sustainability Through Innovation Act of 2017”, (Rep. Hanabusa, D-Hawaii), a bill to authorize Federal agencies to establish prize competitions for innovation or adaptation management development relating to coral reef ecosystems, and for other purposes. Introduced on April 27, 2017 and referred to the House Natural Resources Committee, and in addition to the Science, Space, and Technology Committee.

**H.R. 2330**, the “Yurok Tribe Klamath River Chinook Salmon Emergency Disaster Assistance Act of 2017”, (Rep. Huffman, D-California), a bill to make funds available for fisheries resource disaster assistance for the 2016 Yurok Tribe Klamath River Chinook salmon fishery disaster, and for other purposes. Introduced on May 3, 2017 and referred to the House Appropriations Committee.

**H.R. 2344**, the “Crab Emergency Disaster Assistance Act of 2017”, (Rep. Speier, D-California), a bill to make funds available for fisheries resource disaster assistance for the 2015–16 Dungeness crab and rock crab fisheries disaster, and for other purposes. Introduced on May 3, 2017 and referred to the House Appropriations Committee.

**H.R. 2463**, the “Shark Sales Elimination Act of 2017”, (Rep. Lieu, D-California), a bill to prohibit the sale of shark parts, and for other purposes. Introduced on May 16, 2017 and referred to the House Natural Resources Committee.

**H.R. 2504**, (Rep. Pingree, D-Maine), a bill to ensure fair treatment in licensing requirements for the export of certain echinoderms. Introduced on May 17, 2017 and referred to the House Natural Resources Committee and in addition to the House Foreign Affairs Committee. **On November 8, 2017, the House Natural Resources Committee ordered the bill to be reported. On January 10, 2018, the report to accompany H.R. 2504 was filed, the House Committee on Foreign Affairs was discharged from further consideration, and the bill was placed on the Union Calendar. On February 5, 2018, the House of Representatives passed the bill. On February 6, 2018 the bill was received in the Senate and referred to the Senate Environment and Public Works Committee.**

**H.R. 2560**, the “Reef Assassin Act”, (Rep. Gaetz, R- Florida), a bill to amend the Magnuson-Stevens Fishery Conservation and Management Act to encourage elimination of lionfish from United States waters by allowing individuals to exchange lionfish for tags authorizing fishing for certain species in addition to the number of such species otherwise authorized to be taken by such individuals, and for other purposes. Introduced on May 19, 2017 and referred to the House Natural Resources Committee.

**H. R. 2637**, the “Fishing Safety Training and Research Act”, (Rep. Keating, D-Massachusetts), a bill to amend title 46, United States Code, to reauthorize the Fishing Safety Training Grant Program and the Fishing Safety Research Grant Program. Introduced on May 24, 2017 and referred to the House Transportation and Infrastructure Committee.

**H.R. 2983**, the “Stop the Asian Carp Now Act of 2017”, (Rep. Kaptur, D-Ohio), a bill to direct the Secretary of the Army, acting through the Chief of Engineers, to release an interim report related to aquatic nuisance species control, and for other purposes. Introduced on June 21, 2017 and referred to the House Transportation and Infrastructure Committee.

**H.R. 3041**, the “Aquaculture Risk Reduction Act”, (Rep. Crawford, R-Arkansas), a bill to amend the Lacey Act Amendments of 1981 to provide an exception for a de minimus amount of fish or wildlife included in interstate commercial shipments, and for other purposes. Introduced on June 23, 2017 and referred to the House Natural Resources Committee.

**H.R. 3108**, the “Protecting Honest Fishermen Act of 2017”, (Rep. Farenthold, R-Texas), a bill to strengthen Federal consumer protection and product traceability with respect to commercially marketed seafood, and for other purposes. Introduced on June 29, 2017 and referred to the House Energy and Commerce Committee, and subsequently to the House Agriculture Committee, the House Natural Resources Committee, and the House Ways and Means Committee.

**H.R. 3588**, the “Regionally Empowered Decision-making for Snapper, Noting the Angling Public and the Preservation of an Exceptional Resource Act” or the “RED SNAPPER Act”, (Rep. Graves, R-Louisiana), a bill to amend the Magnuson-Stevens Fishery Conservation and Management Act to provide for management of red snapper in the Gulf of Mexico, and for other purposes. The bill was introduced on July 28, 2017 and referred to the House Natural Resources Committee. *(Note: The Senate version of this bill is S. 1686.)* **The House Natural Resources Committee’s Subcommittee on Water, Power and Oceans held a hearing on this legislation on September 26, 2017. On December 13, 2017, the House Natural Resources Committee ordered the bill to be reported by a recorded vote: 22 - 16.**

**H.R. 3661**, the “Harmful Algal Blooms Solutions Act of 2017” or the “HABS Act of 2017”, (Rep. Mast, R-Florida), a bill to establish a program to award prizes for the development of innovative, environmentally safe solutions for reducing, mitigating, and controlling harmful algal blooms, and for other purposes. Introduced on August 18, 2017 and referred to the House Committee on Science, Space, and Technology, and in addition to the House Committee on Natural Resources, for a period to be subsequently determined by the Speaker.

**H.R. 3665**, the “South Florida Clean Coastal Waters Act of 2017”, (Rep. Mast, R- Florida), a bill to require the Inter-Agency Task Force on Harmful Algal Blooms and Hypoxia to develop a plan for reducing, mitigating, and controlling harmful algal blooms and hypoxia in the Greater Everglades region, and for other purposes. Introduced on August 25, 2017 and referred to the House Committee on Science,

Space, and Technology, and in addition to the House Committee on Natural Resources, for a period to be subsequently determined by the Speaker.

**H.R. 3668**, “Sportsmen’s Heritage and Recreational Enhancement Act” or the “SHARE Act”, (Rep. Duncan, R-South Carolina) a bill to provide for the preservation of sportsmen’s heritage and enhance recreation opportunities on Federal land, and for other purposes. Introduced on September 1, 2017 and referred to the House Committee on Natural Resources, and in addition to the House Committees on Agriculture, the Judiciary, Energy and Commerce, Transportation and Infrastructure, and Ways and Means, for a period to be subsequently determined by the Speaker. *(Note: This legislation often becomes a vehicle for other sportsmen’s provisions including fisheries related provisions.)* The House Natural Resources Committee ordered the legislation to be reported on September 18, 2017. The House Committees on Agriculture, the Judiciary, Energy and Commerce, Transportation and Infrastructure, and Ways and Means were all discharged from further consideration and the bill was placed on the Union Calendar.

**H.R. 3682**, the “Blue Whales and Blue Skies Act”, (Rep. Lowenthal, D-California), a bill to direct the Director of the Office of National Marine Sanctuaries of the National Oceanic and Atmospheric Administration to create a Blue Whales and Blue Skies Program to reduce air pollution and harmful underwater acoustic impacts and the risk of fatal vessel whale strikes by recognizing voluntary reductions in the speed of vessels transiting the Greater Santa Barbara Channel Region, California, and for other purposes. Introduced on September 6, 2017 and referred to the House Committee on Transportation and Infrastructure. *(Note: I am not sure why this legislation was referred to the House Transportation and Infrastructure Committee and not the House Natural Resources Committee.)*

**H.R. 4489**, the “Authorizing Critical Conservation and Enabling Sportsmen and Sportswomen Act” or the “ACCESS Act”, (Rep. Thompson, D-California), a bill to provide for the preservation of America’s outdoor heritage and enhance recreation opportunities on Federal land, and for other purposes. Introduced on November 30, 2017 and referred to the House Natural Resources Committee, and in addition to the Committees on Science, Space, and Technology, the Judiciary, Agriculture, and Transportation and Infrastructure, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

**H.R. 4528**, a bill to make technical amendments to certain marine fish conservation statutes, and for other purposes, (Rep. Soto, D-Florida). Introduced on December 1, 2017 and referred to the House Natural Resources Committee. **On April 17, 2018, the House Natural Resources Committee’s Subcommittee on Water, Power, and Oceans held a hearing on H.R. 4528. On June 6, 2018, the House Natural Resources Committee ordered the bill to be reported by unanimous consent. On June 25, 2018, the full House of Representatives considered and passed the legislation by voice vote and on June 26, 2018 the bill was received in the Senate. On July 26, 2018, the Senate passed this legislation without amendment by unanimous consent. On August 2, 2018, the President signed the bill and it became Public Law No: 115-228.**

**H.R. 4726**, the “Rhode Island Fishermen’s Fairness Act”, (Rep. Langevin, D-Rhode Island), a bill to amend the Magnuson-Stevens Fishery Conservation and Management Act to add Rhode Island to the Mid-Atlantic Fishery Management Council. Introduced on December 21, 2017 and referred to the House Natural Resources Committee.



**H.R. 5061**, the “Shellfish Aquaculture Improvement Act of 2018” (Rep. Sanford, R-South Carolina) a bill to amend title 46, United States Code, to limit recovery for certain injuries incurred in shellfish aquaculture activities if a remedy is available. Introduced the following bill; Introduced on February 15, 2018 and referred to the House Transportation and Infrastructure Committee, and in addition to the House Judiciary Committee, for a period to be subsequently determined by the Speaker.

**H.R. 5248**, the “Sustainable Shark Fisheries and Trade Act” (Rep. Webster, R-Florida), a bill to amend and enhance the High Seas Driftnet Fishing Moratorium Protection Act to improve the conservation of sharks. Introduced on March 13, 2018 and referred to the House Natural Resources Committee and to the House Ways and Means Committee, for a period to be subsequently determined by the Speaker, for consideration of provisions that fall within the jurisdiction of that committee. **On April 17, 2018, the House Natural Resources Committee’s Subcommittee on Water, Power, and Oceans held a hearing on H.R. 5248.**

**H.R. 5269**, the “State and Territorial Approval for Restriction of Fishing Act” or the “STAR Fishing Act” (Rep. Radewagen, R-American Samoa), a bill to require State or territorial approval of restriction by the Secretary of the Interior and the Secretary of Commerce of recreational or commercial fishing access to certain State or territorial waters, respectively. Introduced on March 14, 2018 and referred to the House Natural Resources Committee.

**H. R. 5556**, the “Environmental Compliance Cost Transparency Act of 2018” (Rep. Gosar, R-Arizona), a bill to provide for transparency and reporting related to direct and indirect costs incurred by the Bonneville Power Administration, the Western Area Power Administration, the Southwestern Power Administration, and the Southeastern Power Administration related to compliance with any Federal environmental laws impacting the conservation of fish and wildlife, and for other purposes. Introduced on April 18, 2018 and referred to the House Natural Resources Committee. **On July 11, 2018, the House Natural Resources Committee’s Subcommittee on Water, Power, and Oceans held a hearing on the legislation. On July 18, 2018, the House Natural Resources Committee ordered the legislation (amended) to be reported by unanimous consent.**

**H.R. 5638**, the “Driftnet Modernization and Bycatch Reduction Act” (Rep. Lieu, D- California), a bill to improve the management of driftnet fishing. Introduced on April 26, 2018 and referred to the House Natural Resources Committee.

**H.R. 5996**, the “Coral Reef Conservation Reauthorization Act of 2018” (Rep. Bordallo, D-Guam), a bill to reauthorize and amend the Coral Reef Conservation Act of 2000, and for other purposes. Introduced on June 5, 2018 and referred to the House Natural Resources Committee and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

**H.R. 6212**, the “Imported Seafood Safety Standards Act” (Rep. Higgins, R- Louisiana), a bill to amend the Federal Food, Drug, and Cosmetic Act to ensure the safety of imported seafood. Introduced on June 25, 2018 and referred to the House Energy and Commerce Committee.

**H.R. 6528**, (Rep Moulton, D-Massachusetts) - **To amend the Magnuson-Stevens Fishery Conservation and Management Act to provide fisheries disaster relief for commercial fishery failures that are due to**

certain tariffs imposed by other countries, and for other purposes. Introduced on July 25, 2018 and referred to the House Natural Resources Committee

#### **Senate Fisheries-Related Bills:**

**S. 61**, a bill to remove the sunset provision of section 203 of Public Law 105–384 and for other purposes (Sen. Cantwell, D-Washington). Introduced on January 9, 2017 and referred to the Senate Commerce, Science, and Transportation Committee. *(Note: This is the bill to extend state jurisdiction over the Dungeness crab fishery.)* This legislation was marked up by the Senate Commerce, Science and Transportation Committee on April 5, 2017. The report was filed on June 5, 2017 and the bill was placed on Senate Legislative Calendar.

**S. 396**, (Sen. Nelson, D-Florida) to make technical amendments to certain marine fish conservation statutes, and for other purposes. Introduced on February 15, 2017 and referred to the Senate Commerce, Science, and Transportation Committee. *(Note: this legislation would amend the Billfish Conservation Act of 2012 and the Shark Conservation Act of 2010.)* Note: as mentioned above, this legislation was scheduled to be marked up by the Senate Commerce, Science and Transportation Committee on April 5, 2017, but was withdrawn. Note: On May 18, 2017, the Senate Commerce, Science, and Transportation Committee met in executive session and ordered S. 396 to be reported. On September 19, 2017, the bill was reported without amendment (report No. 115-160) and placed on Senate Legislative Calendar. On October 2, 2017, the Senate passed the bill without amendment by Voice Vote. On October 3, 2017 the bill was referred to the House Natural Resources Committee.

**S. 793**, (Sen. Booker, D-NJ) – Shark Finning prohibition – would prohibit the possession, transportation, the sale or purchase of shark fins or products containing shark fins (with limited exceptions if the shark fin is separated from the shark in a manner consistent with the license or permit and is: 1) destroyed or discarded upon separation; 2) used for noncommercial subsistence purposes in accordance with State or territorial law; or 3) used solely for display or research purposes by a museum, college, or university, or other person under a State or Federal permit to conduct non-commercial scientific research. The bill would impose MSA penalties for violations. Introduced on March 30, 2017 and referred to the Commerce, Science, and Transportation Committee. On May 18, 2017, the Senate Commerce, Science, and Transportation Committee met in executive session and ordered S. 793 to be reported with an amendment in the nature of a substitute.

**S. 859**, the “Great Lakes Fishery Research Authorization Act of 2017”, (Sen. Peters, D-Michigan), a bill to authorize the Director of the United States Geological Survey to conduct monitoring, assessment, science, and research, in support of the binational fisheries within the Great Lakes Basin, and for other purposes. Introduced on April 5, 2017 and referred to the Senate Environment and Public Works Committee.

**S. 958**, the “Coral Reef Sustainability Through Innovation Act of 2017”, (Sen. Hirono, D-Hawaii), a bill to authorize Federal agencies to establish prize competitions for innovation or adaptation management development relating to coral reef ecosystems, and for other purposes. Introduced on April 27, 2017 and referred to the Senate Commerce, Science, and Transportation Committee.

**S. 1322**, the “American Fisheries Advisory Committee Act”, (Sen. Sullivan, R-Alaska), a bill to establish the American Fisheries Advisory Committee to assist in the awarding of fisheries research and development grants, and for other purposes. Introduced on June 8, 2017 and referred to the Senate Commerce, Science, and Transportation Committee. **Ordered to be reported with an amendment in the nature of a substitute by the Committee on Commerce, Science, and Transportation on August 2, 2017. On December 11, 2017, the Committee filed the report and the legislation was placed on the Senate Legislative Calendar. On August 22, 2018, the bill was passed by the Senate with an amendment by Unanimous Consent. The bill was referred to the House Natural Resources Committee.**

**S. 1323**, the “Young Fishermen’s Development Act of 2017”, (Sen. Sullivan, R-Alaska), a bill to preserve United States fishing heritage through a national program dedicated to training and assisting the next generation of commercial fishermen, and for other purposes. Introduced on June 8, 2017 and referred to the Senate Commerce, Science, and Transportation Committee.

**S. 1331**, the “Great Lakes Mass Marking Program Act”, (Sen. Stabenow, D-Michigan), a bill to establish the Great Lakes Mass Marking Program, and for other purposes. Introduced on June 8, 2017 and referred to the Senate Environment and Public Works Committee.

**S. 1398**, the “Stop the Asian Carp Now Act of 2017”, (Sen. Stabenow, D- Michigan), a bill to direct the Secretary of the Army, acting through the Chief of Engineers, to release an interim report related to aquatic nuisance species control, and for other purposes. Introduced on June 21, 2017 and referred to the Senate Environment and Public Works Committee.

**S. 1436**, the “National Fish Habitat Conservation Act”, (Sen. Crapo, R-Idaho), a bill to conserve fish and aquatic communities in the United States through partnerships that foster fish habitat conservation, improve the quality of life for the people of the United States, enhance fish and wildlife-dependent recreation, and for other purposes. Introduced on June 26, 2017 and referred to the Senate Environment and Public Works Committee.

**S. 1520**, the “Modernizing Recreational Fisheries Management Act of 2017” (Sen. Wicker, R-Mississippi), a bill to expand recreational fishing opportunities through enhanced marine fishery conservation and management, and for other purposes. Introduced on July 10, 2017 and referred to the Senate Commerce, Science, and Transportation Committee. **Ordered to be reported with an amendment in the nature of a substitute and with an additional amendment by the Committee on Commerce, Science, and Transportation on February 28, 2018. On June 5, 2018, the Senate Commerce, Science and Transportation Committee filed the report to accompany S. 1520 and the legislation was placed on the Senate Legislative Calendar.**

**S. 1528**, the “Genetically Engineered Salmon Labeling Act”, (Sen. Murkowski, R-Alaska), a bill to amend the market name of genetically altered salmon in the United States, and for other purposes. Introduced on July 11, 2017 and referred to the Senate Health, Education, Labor, and Pensions Committee.

**S. 1686**, the “Regionally Empowered Decision-making for Snapper, Noting the Angling Public and the Preservation of an Exceptional Resource Act” or the “RED SNAPPER Act”, (Sen. Cassidy, R-Louisiana), a bill to amend the Magnuson-Stevens Fishery Conservation and Management Act to provide for management of red snapper in the Gulf of Mexico, and for other purposes. The bill was introduced on August 1, 2017 and was referred to the Senate Commerce, Science, and Transportation Committee.

**S. 1748**, the “Florida Fisheries Improvement Act of 2017”, (Sen. Rubio, R-Florida), a bill to amend the Magnuson-Stevens Fishery Conservation and Management Act to promote sustainable conservation and management for the Gulf of Mexico and South Atlantic fisheries and the communities that rely on them, and for other purposes. The bill was introduced on August 3, 2017 and referred to the Senate Commerce, Science, and Transportation Committee.

**S. 2764**, the “Sustainable Shark Fisheries and Trade Act of 2018” (Sen. Rubio, R-Florida), a bill to amend and enhance the High Seas Driftnet Fishing Moratorium Protection Act to improve the conservation of sharks, and for other purposes. Introduced on April 26, 2018 and referred to the Senate Commerce, Science, and Transportation Committee. **On May 22, 2018, the Senate Commerce, Science, and Transportation Committee ordered the bill to be reported without amendment.**

**S. 2773**, the “Driftnet Modernization and Bycatch Reduction Act” (Sen. Feinstein, D-California), a bill to improve the management of driftnet fishing. Introduced on April 26, 2018 and referred to the Senate Commerce, Science, and Transportation Committee.

**S. 3138**, the “Advancing the Quality and Understanding of American Aquaculture Act” or “AQUAA Act” (Sen. Wicker, R-Mississippi), a bill to establish a regulatory system for marine aquaculture in the United States exclusive economic zone, and for other purposes. Introduced on June 26, 2018 and referred to the Senate Commerce, Science, and Transportation Committee.

**S. 3119**, the “Endangered Salmon Predation Prevention Act”, (Sen. Risch, R-Idaho), a bill to allow for the taking of sea lions on the Columbia River and its tributaries to protect endangered and threatened species of salmon and other nonlisted fish species. Introduced on June 21, 2018 and referred to the Senate Commerce, Science, and Transportation Committee. **On August 1, 2018, the bill was ordered to be reported with an amendment in the nature of a substitute by the Senate Commerce, Science, and Transportation Committee.**

**S. 3315**, the “Predation Reduction of Salmon Act”, (Sen. Merkley, D-Oregon), a bill to allow for the taking of pinnipeds on the Columbia River and its tributaries to protect endangered and threatened species of salmon and other nonlisted fish species. Introduced on July 31, 2018 and referred to the Senate Commerce, Science, and Transportation Committee.

**S. 3331**, the “Fluke Fairness Act of 2018” (Sen. Schumer, D-New York), a bill to provide for an equitable management of summer flounder based on geographic, scientific, and economic data and for other purposes. Introduced on August 1, 2018 and referred to the Committee on Commerce, Science, and Transportation.

**S. 3400**, the “Maritime Security and Fisheries Enforcement Act” or the “Maritime SAFE Act” (Sen. Coons, D-Delaware), a bill to address the threat to national security from illegal, unreported, and unregulated fishing and associated illegal activity, to prevent the illegal trade of seafood and seafood products, and for other purposes. Introduced on August 28, 2018 and referred to the Senate Commerce, Science, and Transportation Committee.

### **Other House Bills of Interest:**

**H.R. 169**, the “West Coast Ocean Protection Act of 2017” (Rep. Huffman, D-California) to amend the Outer Continental Shelf Lands Act to permanently prohibit the conduct of offshore drilling on the outer Continental Shelf off the coast of California, Oregon, and Washington. Introduced on January 3, 2017 and referred to the House Natural Resources Committee.

**H.R. 222**, a bill to “amend the National Marine Sanctuaries Act to prescribe an additional requirement for the designation of marine sanctuaries off the coast of Alaska and for other purposes” (Rep. Young, R-Alaska). Introduced on January 3, 2017 and referred to the House Natural Resources Committee.

**H.R. 310**, the “Southwestern Oregon Watershed and Salmon Protection Act” (Rep. DeFazio, D- Oregon) to withdraw certain land located in Curry County and Josephine County, Oregon, from all forms of entry, appropriation, or disposal under the public land laws, location, entry, and patent under the mining laws, and operation under the mineral leasing and geothermal leasing laws, and for other purposes. Introduced on January 5, 2017 and referred to the House Natural resources Committee.

**H.R. 368**, the “Safeguard Aquaculture Farmers Act” (Rep. Crawford, R-Arkansas) to provide the force and effect of law for certain regulations relating to the taking of double-crested cormorants to reduce depredation at aquaculture facilities and protect public resources. Introduced on January 9, 2017 and referred to the House Natural Resources Committee.

**H.R. 717**, the “Listing Reform Act” (Rep. Olson, R-Texas), to amend the Endangered Species Act of 1973 to require review of the economic cost of adding a species to the list of endangered species or threatened species, and for other purposes. Introduced on January 27, 2017 and referred to the House Natural Resources Committee. **On July 19, 2017, the House Natural Resources Committee held a hearing on this legislation. On October 4, 2017 the House Natural Resources Committee ordered the bill to be Reported by the Yeas and Nays: 22 - 13. On February 15, 2018, the House Natural Resources Committee filed the report to accompany H.R. 1274 and the bill was placed on the Union Calendar.**

**H.R. 845**, the “Ocean Acidification Research Partnerships Act” (Rep. Carbajal, D-California) provide for ocean acidification collaborative research grant opportunities. Introduced on February 3, 2017 and referred to the House Science, Space, and Technology Committee.

**H.R. 961**, the “Ban Aquaculture in the Great Lakes Act” (Rep. Kildee, D-Michigan) to prohibit aquaculture in the Great Lakes. Introduced on February 7, 2017 and referred to the House Natural Resources Committee and the House Agriculture Committee.

**H.R. 1176**, the “Keep America’s Waterfronts Working Act”, (Rep. PIngree, D-Maine) a bill to amend the Coastal Zone Management Act of 1972 to establish a Working Waterfront Task Force and a working waterfronts grant program, and for other purposes. Introduced on February 16, 2017 and referred to the House Natural Resources Committee. **On November 2, 2017, the House Natural Resources Committee’s Water, Power and Oceans Subcommittee held a hearing on the legislation.**

**H.R. 1274**, the “State, Tribal, and Local Species Transparency and Recovery Act” (Rep. Newhouse, R-Washington), a bill to amend the Endangered Species Act of 1973 to require making available to States affected by determinations that species are endangered species or threatened species all data that is the basis of such determinations, and for other purposes. The bill was referred to the House Natural

Resources Committee. On July 19, 2017, the House Natural Resources Committee held a hearing on this legislation. On October 4, 2017 the House Natural Resources Committee ordered the bill to be Reported (Amended) by the Yeas and Nays: 22 - 14. On February 15, 2018, the House Natural Resources Committee filed the report to accompany H.R. 1274 and the bill was placed on the Union Calendar.

**H.R. 1489**, the “Marine Access and State Transparency” or the “MAST Act”, (Rep. Young, R-Alaska), to amend title 54, United States Code, to provide for congressional approval of national monuments and restrictions on the use of national monuments, to establish requirements for declaration of marine national monuments, and for other purposes. Introduced on March 9, 2017 and referred to the House Natural Resources Committee.

**H.R. 2074**, “Public Input for National Monuments Act”, (Rep. Walden, R-Oregon) to require the President to comply with NEPA in designating monuments. Introduced on April 24, 2017 and referred to the House Natural Resources Committee.

**H.R. 2083**, “Endangered Salmon and Fisheries Predation Prevention Act”, (Rep. Beutler, R-Washington), to amend the MMPA to give temporary authorization to issue “eligible entities” to lethally take sea lions on the Columbia River. Introduced on April 24, 2017 and referred to the House Natural Resources Committee. On June 8, 2017, a hearing on this legislation was held by the House Natural Resources Committee’s Water, Power and Oceans Subcommittee. On July 26, 2017, the legislation was ordered to be reported by the House Natural Resources Committee. On September 5, 2017, the report was filed and the bill was placed on the Union Calendar. On June 26, 2018, the full House of Representatives considered and passed the legislation by a roll call vote of 288 – 116. On June 27, 2018, the bill was received in the Senate and referred to the Senate Commerce, Science, and Transportation Committee.

**H.R. 2134**, the “Endangered Species Management Self-Determination Act” (Rep. Luetkemeyer, R-Missouri) to amend the Endangered Species Act of 1973 to permit Governors of States to regulate intrastate endangered species and intrastate threatened species, and for other purposes. Introduced on April 25, 2017 and referred to the House Natural Resources Committee.

**H.R. 2284**, the “National Monument Designation Transparency and Accountability Act”, (Rep. Labrador, R-Idaho), a bill to amend title 54, United States Code, to provide for congressional and State approval of national monuments and restrictions on the use of national monuments. Introduced on May 2, 2017 and referred to the House Natural Resources Committee.

**H.R. 2603**, the “Saving America’s Endangered Species Act” or the “SAVES Act”, (Rep. Gohmert, R-Texas), a bill to amend the Endangered Species Act of 1973 to provide that nonnative species in the United States shall not be treated as endangered species or threatened species for purposes of that Act. Introduced on May 23, 2017 and referred to the House Natural Resources Committee. On July 19, 2017 a hearing on this legislation was held by the House Natural Resources Committee. On October 04, 2017 the House Natural Resources Committee ordered the bill to be Reported (Amended) by the Yeas and Nays: 23 – 16. On February 15, 2018, the House Natural Resources Committee filed the report to accompany H.R. 2603 and the bill was placed on the Union Calendar.

**H.R. 2719**, the “Coastal Communities Ocean Acidification Act of 2017”, (Rep. Pingree, D-Maine), a bill to direct the Secretary of Commerce, acting through the Administrator of the National Oceanic and Atmospheric Administration, to conduct coastal community vulnerability assessments related to ocean

acidification, and for other purposes. Introduced on May 25, 2017 and referred to the House Science, Space and Technology Committee.

**H.R. 2748**, the “Save Our Seas Act of 2017” or the “SOS Act of 2017”, (Rep. Young, R-Alaska), a bill to reauthorize and amend the Marine Debris Act to promote international action to reduce marine debris, and for other purposes. Introduced on May 25, 2017 and referred to the House Transportation and Infrastructure Committee and subsequently to the House Natural Resources Committee.

**H.R. 2755**, the “Beach Act of 2017”, (Rep. Pallone, D-New Jersey) a bill to amend the Federal Water Pollution Control Act relating to beach monitoring, and for other purposes. The bill was introduced on May 26, 2017 and referred to the House Transportation and Infrastructure Committee.

**H. R. 2882**, the “Ocean Acidification Innovation Act of 2017”, (Rep. Kilmer, D- Oregon) to authorize Federal agencies to establish prize competitions for innovation or adaptation management development relating to ocean acidification. Introduced on June 12, 2017 and referred to the House Science, Space, and Technology Committee.

**H.R. 2923**, the “Gulf States Coordination Act” (Rep. Graves, R-Louisiana), a bill to designate the Gulf of Mexico Alliance as a regional coordination partnership of Federal and State actions related to the management of the Gulf of Mexico ecosystem, and for other purposes. Introduced on June 15, 2017 and referred to the House Transportation and Infrastructure Committee and subsequently to the House Natural Resources Committee and the House Science, Space, and Technology Committee.

**H.R. 3021**, the “American Samoa Job Protection & Expansion Act of 2017”, (Rep. Radewagen, R- American Samoa), a bill to amend the Fair Minimum Wage Act of 2007 to stop a scheduled increase in the minimum wage applicable to American Samoa and to provide that any future increases in such minimum wage shall be determined by the Secretary of Labor. Introduced on June 22, 2017 and referred to the House Education and the Workforce Committee.

**H.R. 3131**, the “Endangered Species Litigation Reasonableness Act”, (Rep. Huizenga, R-Michigan), a bill to amend the Endangered Species Act of 1973 to conform citizen suits under that Act with other existing law, and for other purposes. Introduced on June 29, 2017 and referred to the House Natural Resources committee and subsequently to the House Judiciary Committee. **On July 19, 2017 a hearing on this legislation was held by the House Natural Resources Committee. On October 04, 2017 the House Natural Resources Committee ordered the bill to be Reported by the Yeas and Nays: 22 – 16. On February 15, 2018, the House Natural Resources Committee filed the report to accompany H.R. 3133. On February 15, 2018, the House Judiciary Committee was discharged from further consideration and the bill was placed on the Union Calendar.**

**H.R. 3133**, the “Streamlining Environmental Approvals Act of 2017” or the “SEA Act of 2017”, (Rep. Johnson, R-Louisiana), a bill to amend the Marine Mammal Protection Act of 1972 to reduce unnecessary permitting delays by clarifying associated procedures to increase economic development and support coastal restoration programs, and for other purposes. Introduced on June 29, 2017 and referred to the House Natural Resources Committee. **On January 10, 2018, the House Natural Resources Committee ordered the bill to be reported.**

**H.R. 3144**, (Rep. McMorris Rodgers, R-Washington), a bill to provide for operations of the Federal Columbia River Power System pursuant to a certain operation plan for a specified period of time, and for

other purposes. Introduced on June 29, 2017 and referred to the House Natural Resources Committee, and in addition to the Transportation and Infrastructure Committee, for a period to be subsequently determined by the Speaker. On October 12, 2017 the Subcommittee on Water, Power and Oceans held a hearing. On April 11, 2018, the Committee ordered the bill to be reported. On April 18, 2018, the Committee filed the report to accompany H.R. 3144. On April 25, 2018, the House of Representatives passed H.R. 3144. On April 26, 2018, the bill was received in the Senate and referred to the Senate Environment and Public Works Committee.

**H.R. 3377**, the “Justice Attributed to Wounded Sharks Act” or “JAWS Act”, (Rep. Farenthold, R-Texas), a bill to prohibit importation of seafood products of countries that do not prohibit the practice of shark finning, and for other purposes. Introduced on July 25, 2017 and referred to the House Ways and Means Committee.

**H.R. 3608**, the “Endangered Species Transparency and Reasonableness Act”, (Rep. McClintock, R-California), a bill to amend the Endangered Species Act of 1973 to require publication on the Internet of the basis for determinations that species are endangered species or threatened species, and for other purposes. Introduced on July 28, 2017 and referred to the House Natural Resources Committee.

**H.R. 3916**, the “Federally Integrated Species Health Act” or the “FISH Act”, (Rep. Calvert, R-California), a bill to amend the Endangered Species Act of 1973 to vest in the Secretary of the Interior functions under that Act with respect to species of fish that spawn in fresh or estuarine waters and migrate to ocean waters, and species of fish that spawn in ocean waters and migrate to fresh waters. Introduced on October 3, 2017 and referred to the House Natural Resources Committee. On October 12, 2017, the Subcommittee on Water, Power and Oceans held a hearing on the bill. On May 16, 2018, the bill was ordered to be reported (amended) by a roll call vote of 22 – 14 by the House Natural Resources Committee. On July 18, 2018, the report to accompany the bill was filed and the bill was placed on the Union Calendar.

**H.R. 3990**, the “National Monument Creation and Protection Act”, (Rep. Bishop, R-Utah), a bill to amend title 54, United States Code, to reform the Antiquities Act of 1906, and for other purposes. Introduced on October 6, 2017 and referred to the House Natural Resources Committee. On October 11, 2017, the House Natural Resources Committee ordered the bill to be Reported (Amended) by the Yeas and Nays: 23 – 17.

**H.R. 4062**, the “Digital Coast Act” (Rep. Ruppertsberger, D-Maryland), a bill to require the Secretary of Commerce, acting through the Administrator of the National Oceanic and Atmospheric Administration, to establish a constituent-driven program to provide a digital information platform capable of efficiently integrating coastal data with decision-support tools, training, and best practices and to support collection of priority coastal geospatial data to inform and improve local, State, regional, and Federal capacities to manage the coastal region, and for other purposes. Introduced on October 12, 2017 and referred to the House Natural Resources Committee.

**H.R. 4114**, the “Environmental Justice Act of 2017”, (Rep. Ruiz, D-California), a bill to require Federal agencies to address environmental justice, to require consideration of cumulative impacts in certain permitting decisions, and for other purposes. Introduced on October 24, 2017 and referred to the Committee on Energy and Commerce, and in addition to the Committees on Natural Resources,



Transportation and Infrastructure, and the Judiciary, for a period to be subsequently determined by the Speaker.

**H.R. 4306**, the “National Sea Grant College Program Amendments Act of 2017”, (Rep. Huffman, D-California), a bill to reauthorize and amend the National Sea Grant College Program Act, and for other purposes. Introduced on November 8, 2017 and referred to the House Natural Resources Committee.

**H.R. 4417**, the “Harmful Algal Bloom and Hypoxia Research and Control Amendments Act of 2017”, (Rep. Bonamici, D-Oregon), a bill to amend the Harmful Algal Bloom and Hypoxia Research and Control Act of 1998 to address harmful algal blooms, and for other purposes. Introduced on November 16, 2017 and referred to the House Science, Space, and Technology Committee, and in addition to the House Natural Resources Committee, for a period to be subsequently determined by the Speaker.

**H.R. 4465**, the “Endangered Fish Recovery Programs Extension Act of 2017”, (Rep. Curtis, R-Utah), a bill to maintain annual base funding for the Upper Colorado and San Juan fish recovery programs through fiscal year 2023, to require a report on the implementation of those programs, and for other purposes. Introduced on November 28, 2017 and referred to the House Natural Resources Committee. **On December 6, 2017, the House Natural Resources Committee’s Water, Power and Oceans Subcommittee held a hearing. On December 13, 2017, the House Natural Resources Committee ordered the bill to be reported. On February 16, 2018, the House Natural Resources Committee filed the report to accompany H.R. 4465. On March 13, 2018, the House of Representatives passed the bill. On March 14, 2018, the bill was referred to the Senate Energy and Natural Resources Committee.**

**H.R. 4468**, a bill to direct the Secretary of the department in which the Coast Guard is operating to study and report to the Congress regarding recreational vessel operator training (Rep. King, R-New York). Introduced on November 28, 2017 and referred to the House Transportation and Infrastructure Committee.

**H.R. 4489**, the “Authorizing Critical Conservation and Enabling Sportsmen and Sportswomen Act” or the “ACCESS Act”, (Rep. Thompson, D-California), a bill to provide for the preservation of America’s outdoor heritage and enhance recreation opportunities on Federal land, and for other purposes. Introduced on November 30, 2017 and referred to the House Natural Resources Committee, and in addition to the Committees on Science, Space, and Technology, the Judiciary, Agriculture, and Transportation and Infrastructure, for a period to be subsequently determined by the Speaker.

**H.R. 4525**, the “Living Shorelines Act of 2017” (Rep. Pallone, D-New Jersey), a bill to direct the Administrator of the National Oceanic and Atmospheric Administration to make grants to States and local governments and nongovernmental organizations for purposes of carrying out shoreline stabilization projects utilizing natural materials. Introduced on December 1, 2017 and referred to the House Natural Resources Committee.

**H.R. 4647**, the “Recovering America’s Wildlife Act”, (Rep. Fortenberry, R-Nebraska), a bill to amend the Pittman-Robertson Wildlife Restoration Act to make supplemental funds available for management of fish and wildlife species of greatest conservation need as determined by State fish and wildlife agencies, and for other purposes. Introduced on December 14, 2017 and referred to the House Natural Resources Committee. **On February 15, 2018, the House Natural Resources Committee’s Subcommittee on Federal Lands held a hearing.**

**H.R. 4656**, the “Fishing and Small Vessel Relief Act” (Rep. Herrera Beutler, R-Washington), a bill to extend a prohibition relating to permits for discharges incidental to the normal operation of certain vessels. Introduced on December 14, 2017 and referred to the House Transportation and Infrastructure Committee.

**H.R. 5064**, the “Whaling Convention Amendments Act of 2018” (Rep. Young, R-Alaska), a bill to authorize aboriginal subsistence whaling pursuant to the regulations of the International Whaling Commission and for other purposes. Introduced on February 15, 2018 and referred to the House Foreign Affairs Committee.

**H.R. 5196**, the “Commercial Engagement Through Ocean Technology Act of 2018” or the “CENOTE Act of 2018”. (Rep. Mr. Palazzo, R-Mississippi), a bill to require the Under Secretary of Commerce for Oceans and Atmosphere to carry out a program on coordinating the assessment and acquisition by the National Oceanic and Atmospheric Administration of unmanned maritime systems, to make available to the public data collected by the Administration using such systems, and for other purposes. Introduced on March 7, 2018 and referred to the House Natural Resources Committee and Natural Resources, and in addition and to the House Science, Space, and Technology Committee and the House Armed Services Committee, for a period to be subsequently determined by the Speaker, for consideration of provisions that fall within the jurisdiction of those committees.

**H.R. 5875**, a bill to amend the Pittman-Robertson Wildlife Restoration Act and the Dingell-Johnson Federal Aid in Sport Fish Restoration Act, to provide parity for United States territories and the District of Columbia, to make technical corrections to such Acts and related laws, and for other purposes (Rep. Bordallo, D-Guam). Introduced on May 18, 2018 and referred to the House Natural Resources Committee. **On May 22, 2018, the House Natural Resources Committee’s Subcommittee on Federal Lands held a hearing on the legislation. On June 6, 2018, the House Natural Resources Committee ordered the bill to be reported. On July 3, 2018, the House Natural Resources Committee filed the report to accompany H.R. 5875. On July 23, 2018, the House passed the legislation (amended) under Suspension of the Rules by voice vote. The bill has been referred to the Senate Environment and Public Works Committee.**

**H.R. 6060**, the “Scientific Assistance for Very Endangered North Atlantic Right Whales Act of 2018” or the “SAVE Right Whales Act” (Rep. Moulton, D -Massachusetts), a bill to assist in the conservation of the North Atlantic right whale by supporting and providing financial resources for North Atlantic right whale conservation programs and projects of persons with expertise required for the conservation of North Atlantic right whales. Introduced on June 8, 2018 and referred to the House Natural Resources Committee, and in addition to the House Budget Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

**H.R. 6267**, the “Coastal and Ocean Acidification Stressors and Threats Research Act of 2018” or the “COAST Research Act”, (Rep. Bonamici, D- Oregon), a bill to amend the Federal Ocean Acidification Research and Monitoring Act of 2009 to establish an Ocean Acidification Advisory Board, to expand and improve the research on Ocean Acidification and Coastal Acidification, to establish and maintain a data archive system for Ocean Acidification data and Coastal Acidification data, and for other purposes. Introduced on June 28, 2018 and referred to the House Science, Space, and Technology Committee.

**H.R. 6300**, the “National Ocean Policy Act of 2018” (Rep. Panetta, D-California), a bill to give Executive Order 13547, relating to the stewardship of the ocean, the coasts, and the Great Lakes, the full force and effect of law, and for other purposes. Introduced on June 29, 2018 and referred to the House Natural Resources Committee.

**H.R. 6302**, a bill to enact as law certain regulations relating to the taking of double-crested Cormorants, (Rep. Bergman, R- Michigan). Introduced on July 3, 2018 and referred to the House Natural Resources Committee. **On July 11, 2018, the House Natural Resources Committee ordered the bill to be reported by a roll call vote of 19-13.**

**H.R. 6344**, the “Land Ownership Collaboration Accelerates Life Act of 2018” or the “LOCAL Act of 2018” (Rep. Tipton, R-Colorado), a bill to amend the Endangered Species Act of 1973 to encourage voluntary conservation efforts. Introduced on July 12, 2018 and referred to the House Natural Resources Committee.

**H.R. 6345**, the “Ensuring Meaningful Petition Outreach While Enhancing Rights of States Act of 2018” or the “EMPOWERS Act of 2018”, (Rep. Pearce, R-New Mexico), a bill to provide for greater county and State consultation with regard to petitions under the Endangered Species Act of 1973, and for other purposes. Introduced on July 12, 2018 and referred to the House Natural Resources Committee.

**H.R. 6346**, the “Weigh Habitats Offsetting Locational Effects Act of 2018” or the “WHOLE Act of 2018” (Rep. Johnson, R-Louisiana), a bill to amend the Endangered Species Act of 1973 to provide for consideration of the totality of conservation measures in determining the impact of proposed Federal agency action. Introduced on July 12, 2018 and referred to the House Natural Resources Committee.

**H.R. 6362**, the “Invasive Fish and Wildlife Prevention Act of 2018” (Rep. Stefanik, R-New York), a bill to establish an improved regulatory process to prevent the introduction and establishment in the United States of injurious wildlife. Introduced on July 12, 2018 and referred to the House Natural Resources Committee, and in addition to the Committees on the Judiciary, Ways and Means, and the Budget, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

**H.R. 6434**, a bill to amend section 7 of Public Law 100–515 (16 U.S.C. 1244 note) to promote continued use of the James J. Howard Marine Sciences Laboratory at Gateway National Recreation Area by the National Oceanic and Atmospheric Administration (Rep. Pallone, D-New Jersey). (Note: the bill would authorize the transfer of this facility and property from the State of New Jersey to NOAA.) Introduced on July 18, 2018 and referred to the House Natural Resources Committee.

**H.R. 6645**, the “Harmful Algal Bloom and Hypoxia Research and Control Act of 2018”, (Rep. Mast, R-Florida). Introduced on July 31, 2018 and referred to the House Science, Space, and Technology Committee, and in addition to the House Natural Resources Committee, for a period to be subsequently determined by the Speaker.

**H.R. 6660**, the “National Fish Habitat Conservation Through Partnerships Act” (Rep. Wittman, R-Virginia), a bill to encourage partnerships among public agencies and other interested persons to promote fish conservation. Introduced on August 7, 2018 and referred to the House Natural Resources Committee.

**H.R. 6665**, the “Offshore Wind for Territories Act” (Rep. Bordallo, D-Guam), a bill to amend the Outer Continental Shelf Lands Act to apply to territories of the United States, to establish offshore wind lease sale requirements, to provide dedicated funding for coral reef conservation, and for other purposes. Introduced on August 10, 2018 and referred to the House Natural Resources Committee.

**H.R. 6668**, the “Modifying Unaccountable Standards and Simplifying Endangered Lists” or the “MUSSELS Act”, (Rep. Rokita, R-Indiana), a bill to amend the Endangered Species Act of 1973 to remove freshwater mussels from the list of endangered and threatened species. Introduced on August 10, 2018 and referred to the House Natural Resources Committee.

#### **Other Senate Bills of Interest:**

**S. 31**, the “West Coast Ocean Protection Act of 2017” (Sen. Wyden, D-Oregon) to amend the Outer Continental Shelf Lands Act to permanently prohibit the conduct of offshore drilling on the outer Continental Shelf off the coast of California, Oregon, and Washington. Introduced on January 4, 2017 and referred to the Senate Energy and Natural Resources Committee.

**S. 33**, the “Improved National Monument Designation Process Act” (Sen. Murkowski, R-Alaska), to provide for congressional approval of national monuments and restrictions on the use of national monuments, to establish requirements for the declaration of marine national monuments, and for other purposes. Introduced on January 5, 2017 and referred to the Senate Energy and Natural Resources Committee.

**S. 110**, the “Digital Coast Act”, (Sen. Baldwin, D-Wisconsin), a bill to require the Secretary of Commerce, acting through the Administrator of the National Oceanic and Atmospheric Administration, to establish a constituent-driven program to provide a digital information platform capable of efficiently integrating coastal data with decision-support tools, training, and best practices and to support collection of priority coastal geospatial data to inform and improve local, State, regional, and Federal capacities to manage the coastal region, and for other purposes. Introduced on January 12, 2017 and referred to the Senate Commerce, Science, and Transportation Committee. **On January 24, 2017 the Senate Commerce, Science, and Transportation Committee ordered the bill to be reported without amendment. On March 30, 2017 the report was filed and the bill was placed on Senate Legislative Calendar under General Orders. On May 25, 2017 the bill passed Senate without amendment by Unanimous Consent.**

**S. 132**, the “National Monument Designation Transparency and Accountability Act of 2017” (Sen. Crapo, R-Idaho), to amend title 54, United States Code, to provide for congressional and State approval of national monuments and restrictions on the use of national monuments. Introduced on January 12, 2017 and referred to the Senate Energy and Natural Resources Committee.

**S. 376**, the “21st Century Endangered Species Transparency Act”, (Sen. Cornyn, R-Texas), to amend the Endangered Species Act of 1973 to require publication on the Internet of the basis for determinations that species are endangered species or threatened species, and for other purposes. Introduced on February 14, 2017 and referred to the Senate Environment and Public Works Committee.

**S. 756**, the “Save Our Seas Act of 2017”, (Sen. Sullivan, R-Alaska), a bill to reauthorize and amend the Marine Debris Act to promote international action to reduce marine debris, and for other purposes.

Introduced on March 29, 2017 and referred to the Senate Commerce, Science, and Transportation Committee. On April 5, 2017, the Senate Commerce, Science, and Transportation Committee met in executive session and ordered S. 756 to be reported. On July 24, 2017, the report to accompany S. 756 was filed (Report #115-135). On August 3, 2017, the Senate passed the bill with amendments by Unanimous Consent. On August 4, 2017, the bill was referred to the House Committee on Transportation and Infrastructure, and in addition to the House Committee on Natural Resources, for a period to be subsequently determined by the Speaker. On June 27, 2018, the House Transportation and Infrastructure Committee considered the bill and ordered it to be reported. (Note: this legislation was also referred to the House Natural Resources Committee.) On July 25, 2018, the House of Representatives passed the bill (amended) under Suspension of the Rules by voice vote. On July 26, 2018, the bill was received in the Senate.

**S. 935**, the “Endangered Species Management Self-Determination Act”, (Sen. Paul, R-Kentucky), a bill to amend the Endangered Species Act of 1973 to permit Governors of States to regulate intrastate endangered species and intrastate threatened species, to amend the Migratory Bird Treaty Act to permit the taking of certain black vultures and ravens, and for other purposes. Introduced on April 25, 2017 and referred to the Senate Environment and Public Works Committee.

**S. 1036**, the “Marine Energy Act”, (Sen. Wyden, D-Oregon), a bill to promote research, development, and demonstration of marine and hydrokinetic renewable energy technologies, and for other purposes. Introduced on May 3, 2017 and referred to the Senate Energy and Natural Resources Committee.

**S. 1057**, the “Harmful Algal Bloom and Hypoxia Research and Control Amendments Act of 2017”, (Sen. Nelson, D-Florida), a bill to amend the Harmful Algal Bloom and Hypoxia Research and Control Act of 1998 to address harmful algal blooms, and for other purposes. . Introduced on May 4, 2017 and referred to the Senate Commerce, Science, and Transportation Committee. **Ordered reported by the Senate Commerce, Science and Transportation Committee on May 18, 2017. The report was filed on August 3, 2017 and the bill was placed on Senate Legislative Calendar. On September 26, 2017, the Senate passed the bill with an amendment by Voice Vote.**

**S. 1100**, the (Sen. Baldwin, D-Wisconsin), a bill to amend title 46, United States Code, to authorize appropriations for the program to provide assistance for small shipyards and maritime communities through fiscal year 2020, and for other purposes. Introduced on May 11, 2017, and referred to the Senate Commerce, Science, and Transportation Committee.

**S. 1214**, the “Hunting, Fishing, and Recreational Shooting Protection Act”, (Sen. Thune, R-South Dakota), a bill to amend the Toxic Substances Control Act to clarify the jurisdiction of the Environmental Protection Agency with respect to certain sporting good articles, and to exempt those articles from a definition under that Act. Introduced on May 24, 2017 and referred to the Senate Environment and Public Works Committee.

**S. 1234**, the “Everglades for the Next Generation Act”, (Sen. Nelson, D-Florida), a bill to amend the Water Resources Development Act of 2000 to provide for expedited project implementation relating to the comprehensive Everglades restoration plan. Introduced on May 25, 2017 and referred to the Senate Environment and Public Works Committee.

**S. 1332**, the “Great Lakes Aquatic Connectivity and Infrastructure Program Act”, (Sen. Stabenow, D-Michigan) a bill to establish the Great Lakes Aquatic Connectivity and Infrastructure Program, and for other purposes. Introduced on June 8, 2017 and referred to the Senate Environment and Public Works Committee.

**S. 1373**, the “Gulf States Protection and Restoration Coordination Act”, (Sen. Wicker, R-Mississippi) a bill to designate the Gulf of Mexico Alliance as a Regional Coordination Partnership of the National Oceanic and Atmospheric Administration, and for other purposes. Introduced on June 15, 2017 and referred to the Senate Commerce, Science, and Transportation Committee.

**S. 1425**, the “Coordinated Ocean Monitoring and Research Act”, (Sen. Wicker, R-Mississippi), a bill to reauthorize the Integrated Coastal and Ocean Observation System Act of 2009, and for other purposes. Introduced on June 22, 2017 and referred to the Senate Commerce, Science, and Transportation Committee. **Ordered to be reported with an amendment in the nature of a substitute by the Committee on Commerce, Science, and Transportation on August 2, 2017. On November 27, 2017, the Committee filed the report and the legislation was placed on the Senate Legislative Calendar. On January 8, 2018, the bill passed the Senate with an amendment by Unanimous Consent. On January 9, 2018, the bill was referred to the House Science, Space, and Technology Committee, and in addition, the House Natural Resources Committee.**

**S. 1586**, a bill to require the Under Secretary for Oceans and Atmosphere to update periodically the environmental sensitivity index products of the National Oceanic and Atmospheric Administration for each coastal area of the Great Lakes, and for other purposes, (Sen. Peters, D-Michigan). Introduced on July 19, 2017 and referred to the Senate Commerce, Science and Transportation Committee. **Ordered to be reported with an amendment in the nature of a substitute by the Committee on Commerce, Science, and Transportation on August 2, 2017.**

**S. 1702**, the “Endangered Salmon and Fisheries Predation Prevention Act”, (Sen. Risch, R-Idaho), a bill to amend the Marine Mammal Protection Act of 1972 to reduce predation by sea lions on endangered Columbia River salmon and other species not listed under the Endangered Species Act of 1973, and for other purposes. The bill was introduced on August 2, 2017 and was referred to the Senate Commerce, Science, and Transportation Committee.

**S. 1747**, the “Florida Manatee Research and Recovery Act”, (Sen. Nelson, D-Florida), a bill to authorize research and recovery activities to provide for the protection, conservation, and recovery of the Florida manatee, and for other purposes. The bill was introduced on August 3, 2017 and was referred to the Senate Commerce, Science, and Transportation Committee.

**S. 1839**, the “Cultivating Revitalization by Expanding American Agricultural Trade and Exports Act” or the “CREAATE Act”, (Sen. King, I-Maine), a bill to amend the Agricultural Trade Act of 1978 to extend and expand the market access program and the foreign market development cooperator program. September 19, 2017 and referred to the Senate Committee on Agriculture, Nutrition, and Forestry. (Note: While primarily focused on agricultural products, the bill does mention seafood.)

**S. 1863**, the “Native Species Protection Act” (Sen. Lee, R-Utah), a bill to clarify that noncommercial species found entirely within the borders of a single State are not in interstate commerce or subject to regulation under the Endangered Species Act of 1973 or any other provision of law enacted as an

exercise of the power of Congress to regulate interstate commerce. Introduced on September 26, 2017 and referred to the Senate Committee on Environment and Public Works.

**S. 1965**, the “Allowing Alaska to Improve Vital Opportunities in the Rural Economy Act” or the “Allowing Alaska IVORY Act”, (Sen. Sullivan, R-Alaska), a bill to amend the Marine Mammal Protection Act of 1972 to protect the cultural practices and livelihoods of producers of Alaska Native handicrafts and traditional mammoth ivory products, and for other purposes. Introduced on October 17, 2017 and referred to the Senate Commerce, Science, and Transportation Committee.

**S. 1996**, the “Environmental Justice Act of 2017”. (Sen. Booker, D-New Jersey), a bill to require Federal agencies to address environmental justice, to require consideration of cumulative impacts in certain permitting decisions, and for other purposes. Introduced on October 24, 2017 and referred to the Senate Environment and Public Works Committee.

**S. 2071**, the “Sustainable Fishing Workforce Protection Act”, (Sen. Hirono, D-Hawaii), a bill to authorize the temporary entry into the United States of alien crewmen employed on longline fishing vessels originating in Hawaii, to ensure that such aliens receive reasonable wages and working conditions, and to provide for appropriate enforcement and oversight of fishing companies employing such aliens. Introduced on November 2, 2017 and referred to the Senate Judiciary Committee.

**S. 2166**, the “Endangered Fish Recovery Programs Extension Act of 2017”, (Sen. Gardner, R-Colorado), a bill to maintain annual base funding for the Upper Colorado and San Juan fish recovery programs through fiscal year 2023, to require a report on the implementation of those programs, and for other purposes. Introduced on November 28, 2017 and referred to the Senate Energy and Natural Resources Committee.

**S. 2194**, the “Fishing and Small Vessel Relief Act” (Sen. Cantwell, D-Washington), a bill to remove a limitation on a prohibition relating to permits for discharges incidental to normal operation of vessels. Introduced on December 5, 2017 and referred to the Senate Environment and Public Works Committee.

**S. 2229**, the “Coastal Communities Ocean Acidification Act of 2017” (Sen. Murkowski, R-Alaska), a bill to direct the Secretary of Commerce, acting through the Administrator of the National Oceanic and Atmospheric Administration, to conduct coastal community vulnerability assessments related to ocean acidification, and for other purposes. Introduced on December 14, 2017 and referred to the Senate Commerce, Science, and Transportation Committee.

**S. 2264**, the “Rhode Island Fishermen’s Fairness Act of 2017”, (Sen. Reed, D-Rhode Island), a bill to amend the Magnuson-Stevens Fishery Conservation and Management Act to add Rhode Island to the Mid-Atlantic Fishery Management Council, and for other purposes. Introduced on December 21, 2017 and referred to the Senate Commerce, Science, and Transportation Committee.

**S. 2273**, a bill to extend the period during which vessels that are shorter than 79 feet in length and fishing vessels are not required to have a permit for discharges incidental to the normal operation of the vessel, (Sen. Sullivan, R-Alaska). Introduced on December 21, 2017. The bill considered and passed by the Senate on December 22, 2017. On December 22, 2017, the House of Representatives passed the bill by unanimous consent.

**S. 2331**, a bill to extend the period during which vessels that are shorter than 79 feet in length and fishing vessels are not required to have a permit for discharges incidental to the normal operation of the vessel (Sen. Sullivan, R-Alaska). Introduced on January 23, 2018 and referred to the Senate Commerce, Science, and Transportation Committee.

**S. 2354**, the "America's Natural Treasures of Immeasurable Quality Unite, Inspire, and Together Improve the Economies of States (ANTIQUITIES) Act of 2018", (Sen. Udall, D-NM), to provide for the administration of certain national monuments, to establish a National Monument Enhancement Fund, and to establish certain wilderness areas in the States of New Mexico and Nevada. Introduced on January 30, 2018 and referred to the Senate Energy and Natural Resources Committee. (Note: the bill text is not yet available online.)

**S. 2369**, the "Whaling Convention Amendments Act of 2018" (Sen. Sullivan, R-Alaska), a bill to authorize aboriginal subsistence whaling pursuant to the regulations of the International Whaling Commission, and for other purposes. Introduced on February 5, 2018 and Senate Commerce, Science, and Transportation Committee. **On April 25, 2018, the Senate Commerce, Science, and Transportation Committee ordered the bill to be reported.**

**S. 2472**, the "Coastal Coordination Act of 2018" (Sen. Nelson, D-Florida), a bill to reauthorize the Coastal Zone Management Act of 1972, and for other purposes. Introduced on February 28, 2018 and referred to the Senate Commerce, Science, and Transportation Committee.

**S. 2511**, the "Commercial Engagement Through Ocean Technology Act of 2018" or the "CENOTE Act of 2018" (Sen. Wicker, R-Mississippi), a bill to require the Under Secretary of Commerce for Oceans and Atmosphere to carry out a program on coordinating the assessment and acquisition by the National Oceanic and Atmospheric Administration of unmanned maritime systems, to make available to the public data collected by the Administration using such systems, and for other purposes. Introduced on March 7, 2018 and referred to the Senate Commerce, Science, and Transportation Committee. **On April 25, 2018, the Senate Commerce, Science, and Transportation Committee ordered the bill to be reported. On July 9, 2018, the report to accompany the bill was filed and the bill was placed on the Senate Legislative Calendar.**

**S. 2587**, a bill to amend the Endangered Species Act of 1973 to establish a program to allow States to assume certain Federal responsibilities under that Act with respect to agency actions applicable to highway projects within the States, and for other purposes (Sen. Cornyn, R-Texas). Introduced on March 21, 2018 and referred to the Senate Environment and Public Works Committee.

**S. 2623**, a bill to require the Secretary of Transportation to modify hours of service requirements to include all fish in the definition of "agricultural commodity" and for other purposes. Introduced on March 22, 2018 and referred to the Senate Commerce, Science, and Transportation Committee.

**S. 2778**, the "Saving America's Vulnerable and Endangered Species Act" or the "SAVES Act" (Sen. Cruz, R-Texas), a bill to amend the Endangered Species Act of 1973 to include a prohibition on the listing of a living nonnative species as a threatened species or an endangered species, and for other purposes. Introduced on April 26, 2018 and referred to the Senate Environment and Public Works Committee.

**S. 2783**, the "Coastal Communities Adaptation Act" (Sen. Nelson, D-Florida), a bill to improve the resilience of the built and natural environment to natural disasters and climate change using, among



other measures, natural and nature-based features, and for other purposes. Introduced on April 26, 2018 and referred to the Senate Commerce, Science, and Transportation Committee.

**S. 3087**, the “Living Shorelines Act of 2018” (Sen. Harris, D-California), a bill to direct the Administrator of the National Oceanic and Atmospheric Administration to make grants to State and local governments and nonprofit organizations for purposes of carrying out shoreline stabilization projects utilizing natural materials that support natural habitats and ecosystem functions, and for other purposes. Introduced on June 19, 2018 and referred to the Senate Commerce, Science, and Transportation Committee.

**S. 3206**, the “Toxic Algae Tax Relief Act” (Sen. Nelson, D-Florida), a bill to amend the Internal Revenue Code of 1986 to provide tax relief to areas affected by toxic algal blooms. Introduced on July 12, 2018 and referred to the Senate Finance Committee.

**S. 3210**, the “Invasive Fish and Wildlife Prevention Act” (Sen. Gillibrand, D-New York), a bill to establish an improved regulatory process to prevent the introduction and establishment in the United States of injurious wildlife Introduced on July 12, 2018 and referred to the Senate Environment and Public Works Committee.

**S. 3223**, the “Recovering America’s Wildlife Act” (Sen. Risch, R-Idaho), a bill to amend the Pittman-Robertson Wildlife Restoration Act to make supplemental funds available for the management of fish and wildlife species of greatest conservation need, as determined by State fish and wildlife agencies, and for other purposes. Introduced on July 17, 2018 and referred to the Senate Environment and Public Works Committee.

**S. 3265**, the “Waterfront Community Revitalization and Resiliency Act of 2018” (Sen. Baldwin, D-Wisconsin), a bill to require the Secretary of Commerce to undertake certain activities to support waterfront community revitalization and resiliency, and for other purposes. Introduced on July 25, 2018 and referred to the Senate Commerce, Science, and Transportation Committee. **On August 1, 2018, the bill was ordered to be reported by the Senate Commerce, Science, and Transportation Committee.**

**S. 3374** , (Sen. Rubio, R-Florida), a bill to require the Inter-Agency Task Force on Harmful Algal Blooms and Hypoxia to develop a plan for reducing, mitigating, and controlling harmful algal blooms and hypoxia in South Florida, and for other purposes. Introduced on August 23, 2018 and referred to the Senate Commerce, Science, and Transportation Committee.

**S. 3394**, the “Comprehensive National Mercury Monitoring Act” (Sen. Collins, R-Maine), a bill to establish a national mercury monitoring program, and for other purposes. Introduced on August 28, 2018 and referred to the Senate Environment and Public Works Committee.

### **House Resolutions, and Senate Resolutions:**

*(Note: House and Senate Resolutions, do not carry the force of law, but are a way for House and Senate Members to show support or opposition for various causes or industries. Because they do not carry the force of law, I have not included them in my reports, but having seen two recently-introduced Senate Resolutions that pertained to fisheries, I thought I would start including them from now on. If people would like to see Resolutions from earlier in this Congress, I can update this section to include all introduced Resolutions from the 115<sup>th</sup> Congress. Let me know.)*

**S. Res. 598** - A resolution calling upon the United States Senate to give its advice and consent to the ratification of the United Nations Convention on the Law of the Sea.

**S. Res. 599** - A resolution designating September 25, 2018, as "National Lobster Day".
